**RESOLUTION**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF TUOLUMNE**

to support the application, planning and implementation process for Tuolumne County to join the American Association of Retired Persons (AARP) Network of Age-Friendly States and Communities

- WHEREAS,** the population of people aged 65 and over in the United States is expected to increase from 54 million to more than 94 million in 2050; and
- WHEREAS,** the federally funded Older Americans Act (OAA) identifies individuals aged 60 and older as eligible for senior programs and services; and
- WHEREAS,** one third of the population in Tuolumne County is aged 60 and older; and
- WHEREAS,** as California's older population is growing, the economic security of older adults across the state is diminishing, with increased housing and healthcare costs, rising inequality, and cuts to critical safety net programs leaving many older adults without sufficient income to meet their basic needs; and
- WHEREAS,** in 2012, AARP created the Age-Friendly Network to engage and mobilize communities to create and support livable areas and improve quality of life for people of all ages; and
- WHEREAS,** all ages benefit from the adoption of policies and programs that make neighborhoods walkable, feature transportation options, enable access to key services, provide opportunities to participate in community activities, and support housing that's affordable and adaptable; and
- WHEREAS,** Well-designed, age-friendly communities foster economic growth and make for happier, healthier residents;

**NOW THEREFORE BE IT RESOLVED** that the Board of Supervisors supports the application, planning and implementation process for Tuolumne County to join the AARP Network of Age-Friendly States and Communities.
